- To undertake, in the event of a change of mind and cancellation of departure, to **promptly communicate his/her withdrawal**, to SEND, to his/her home University and to the host organisation. In the event of withdrawal from an ongoing mobility, the undersigned also undertakes to reimburse any funds already disbursed by SEND but not used or forfeited.
